ORDINANCE NO. 03, S. 1993

AN ORDINANCE REQUIRING ALL OWNERS OF TRICYCLES WHICH ARE NOT FOR HIRE TO SECURE AN OPERATOR'S PERMIT, PROVIDING FOR THE TERMS AND CONDITIONS FOR ITS OPERATION AND PRESCRIBING PENALTIES FOR VIOLATIONS THEREOF

BE IT ORDAINED by the Sangguniang Bayan of BATAc, Ilocos Norte;

- Section 1. That this ordinance is enacted pursuant to RA 7160, otherwise known as the Local Government Code of 1991, the pertinent provisions of which is Section 447 paragraph 3, empowering the Sangguniang Bayan to authorize issuance of permits;
- Section 2. That tricycles which are Not-For-Hire are those motor vehicles composed of a motorcycle fitted with a single wheel side car or a motorcycle with a two-wheel cab and which are operated for the private use of the owner as distinguished from a tricycle with a Motorized Tricycle Operator's Permit (MTOP) which is intended for the public for a fee;
- Section 3. That tricycles which are Not-For-Hire shall secure a permit from the Mayor's Office before they can operate and shall be issued side car numbers;
- Section 4. That the permit to operate Not-For-Hire tricycles shall be noted for one year and renewable for every year of operation; on or before its expiry date;
- Section 5. That any tricycle Not-For-Hire without the prescribed permit and body number found operating within the jurisdiction of the municipality shall be impounded and shall only be released upon payment of the fine of Five Hundred (P500.00) Pesos; If the unit is found to be transporting passengers for a fee, the fine shall be One Thousand (P1,000.00) Pesos;
- Section 6. That this ordinance shall take effect the day following its publication or posting whichever occurs later.


