ORDINANCE NO. 04, S. 1993

AN ORDINANCE DESIGNATING A TERMINAL FOR PUBLIC UTILITY BUSES (PUB) AND PUBLIC UTILITY JEEPNEYS (PUJ) AND COLLECTING A TERMINAL FEE FOR THE USE THEREOF AND FOR OTHER PURPOSES

BE IT ORDAINED by the Sangguniang Bayan of Batac, Ilocos Norte that:

- Section 1. This ordinance is enacted pursuant to the provisions of RA 7160 otherwise known as the Local Government Code of 1991, the pertinent provision of which is Section 447, paragraph 5, (V) empowering the Sangguniang Bayan to establish bus terminals and regulate the use of the same, and to regulate the use of STREETS AND OTHER PUBLIC PLACES to ensure the efficient and effective delivery of basic public service;
- Section 2. A portion of the Batac Public Market Compound which is owned by the Municipality, particularly in front of the Joey Lina Building, is hereby designated as the Terminal for Public Utility Buses (PUB) and Public Utility Jeeps (PUJ);
- Section 3. A terminal fee of Five (P5.00) Pesos per day for Mini-Buses and Four (P4.00) Pesos per day for Jeeps shall be collected from these Public Utility Buses (PUB) and Public Utility Jeeps (PUJ) which shall avail of the facilities of said terminal, which shall have waiting time for passengers;
- Section 4. That any ordinance inconsistent with the provisions of this ordinance is hereby repealed;
- Section 5. This Ordinance shall take effect immediately on the day following its publication in a newspaper of general circulation or at the end of the posting period, whichever occurs later.
