ORDINANCE NO. 04 S. 1999

**AN ORDINANCE DESIGNATING PORTIONS OF THE MUNICIPALITY OF
BATAC-OWNED GOVERNMENT CENTER LAND CONSISTING OF THREE
POINT NINETY SEVEN ZERO EIGHT [3.9708 HAS.] HECTARES, MORE OR
LESS, AS THE SITE FOR THE BUILDINGS AND FACILITIES OF OFFICES
AND AGENCIES OF THE NATIONAL GOVERNMENT TO INCLUDE
GOVERNMENT OWNED OR CONTROLLED CORPORATIONS**

BE IT ENACTED by the Sangguniang Bayan in session duly assembled and by authority of the same that:

Section 1. Except as otherwise provided for by a municipal ordinance, portions of the Municipality of Batac-owned Government Center land located in Barangay Quiling Sur and Quiling Norte consisting of three point ninety seven zero eight [3.9708 has.] hectares more or less, is designated and reserved for the buildings and facilities of offices and agencies of the National Government to include government owned or controlled corporations;

Section 2. The portions of land referred to above shall be exclusive of Block 1: lots Nos. 1, 2, 3, 4, 5, 6, 7, 8, 9 and 10, Block 2: lots Nos. 1, 2, 3, 4, 5, 6, 7, and 8, Block 3: lots Nos. 1, 2, 3, 4, 5, 6, 7, and 8, Block 4: lots Nos. 3, 4, 5, 6, 7, 8, 9, and 10, Block 5:
