ORDINANCE NO. 05, 8, 1995

AN ORDINANCE PROHIBITING THE INDISCRIMINATE OR DESTRUCTIVE CUTTING OF TRESS AND PROVIDING PENALTIES FOR VIOLATION THEREOF

BE IT CREAKED by the Sanguniang Bayan of RATAC, Ilocos Horte that:

Minimize, pursuant to the provisions of RA 7160 otherwise known as the Local Covernment Code of 1991, the pertiont provision of which is Section 447, par 1. (VI) empowering the Sangauniang Dayon to enact measures to protect the environment, the indiscriminate cutting of trees within the municipality is hereby prohibited;

- Section: 1. Indiscriminate or destructive outling of trees shall mean the cutting of more than five (5) trees of any kind or less than five (5) trees if in the opinion of the Sangguniang Barargay concerned, such will result in an ecological imbalance;
- Section 2. It shall be unlawful for any person to cut trees as defined in the preceding section within the Humicipality;
- Section 3. Any person violating this Ordinance shall suffer the penalty of a fine of not less than CHE THOUSARD (P1,000,00) PESOS nor more than TWO THOUSAND PIVE HUNDRED (P2,500000) PESOS or imprisonment of not less than one (1) month or more than six (6) months of both fine and imprisonment at the discretion of the court:

In addition, the chainsay or any instrument of cutting used in violation of this Ordinance shall be forefeited in favor of the Municipal Government. The court shall further order the confiscation in favor of the Municipal Government the trees cut;

- Section 4. The proceeds of the fine and the cut trees confiscated shall be shared equally by the Borangay concerned and the Municipal Government;
- Section 5. For this purpose, the Barangay Officials are hereby tasked to share in the responsibility of implementing this ordinance in their respective Barangays and of preventing violations of this ordinance by requiring that all trees out in their respective jurisdiction shall also need a percit from the Sangguniang Barangay;
- Section 6. This Ordinance shall take effect the day following its publication or posting whichever occurs later.
