ORDINANCE NO. 06

Be it ordained by the Municipal Council of Batac, Ilocos Norte  
that:

- Section 1. Vehicles coming from Paoy upon entering the poblacion from the twin gates of the Mariano Marcos State University Batac to Bantay-Batac and vice-versa will reduce their speeds to 20 kilometers per hour;
- Section 2. Within this area, overtaking or passing over another moving vehicles (passenger trucks and jeepneys, cargo trucks and automobiles) shall be strictly prohibited;
- Section 3. All motor vehicle drivers, including tricycle drivers shall be furnished a copy of this ordinance;
- Section 4. All policemen of this municipality are empowered to apprehend all drivers violating the provisions of Sections 1 and 2 of this ordinance and violators shall be brought to the Office of the Chief of Police for appropriate action;
- Section 5. Any driver driving in excess of the allowable rate of speed shall be penalized;
- Section 6. All traffic violators will suffer the following penalties: a fine of P50.00 for the first offense; P100.00 for the second offense; P150.00 for the third offense; and imprisonment of not more than 20 days for the fourth offense; and that this ordinance shall take effect immediately upon approval.

Enacted this 27th day of August, 1990 in Batac, Ilocos Norte.
