ORDINANCE NO. 07

Series of 1992

PROHIBITING AND PENALIZING THE OWNER OR OWNERS OF ALL
ANIMALS FROM GRAZING OR LETTING ASTRAY ALONG PUBLIC
PLACES WITHIN BATAc

BE IT ORDAINED by the Sangguniang Bayan of Batac, Ilocos Norte
that:

Section 1. No person or persons shall be allowed to graze or
let astray his animal or animals within the public places of BATAc;

Section 2. The animal or animals including the astray causing
destruction to plants and trees will be taken by the barangay offi-
cials to be placed in the corral built for the purpose;

Section 3. That the animal or animals will only be released
upon payment of a fine of Three Hundred (P300.00) Pesos for the
first offense; Four Hundred (P400.00) Pesos and imprisonment of
fifteen (15) days for the second offense; and Five Hundred Pesos
(P500.00) and imprisonment for thirty (30) days for the third
offense for the same animal or another animal but the same owner;
Provided, that in the event the grazed or let astray animal or
animals caused hazard to motorists, the fines as prescribed will
be doubled;

Section 4. That the Barangay Officials shall be deputized
to collect the penalties and fifty (50%) per cent of the amount
collected shall accrue to the Barangay Funds as incentive;

Section 5. That this Ordinance shall take effect ten (10)
days after posting or publication in a local newspaper of
general circulation in Ilocos Norte.
