**ORDINANCE NO. 07
Series 1999**

**AN ORDINANCE AMENDING SECTIONS 3 AND 4 OF ORDINANCE NO. 02
S. 1992 ENTITLED MUNICIPAL TRAFFIC AND LAND TRANSPORTATION
ORDINANCE AND PROVIDING PENALTIES FOR VIOLATION/S THEREOF**

BE IT ORDAINED by the Sangguniang Bayan of Batac in session duly assembled that:

Section 1. Section 3 of the aforequoted ordinance presently reads:

Loading and Unloading Zones

- a. Loading and Unloading Zones for Mini Bus with waiting time -
 1. In front of New Chua's Building/Iliga Bakery going South;
 2. Service Road in front of New Public Market going North and South;
 3. In front of Roman Catholic Church going North.
- b. Loading and Unloading Zones For Public Utility Jeepneys with waiting time -
 1. In front of Ricarte Park - Kingsland going North;
 2. In front of Rendezvous Restaurant going South, one at a time; waiting PUJ to park along Arellano and La Bataqueño and Civil Streets.
- c. Parking of vehicles other than the above-mentioned in the designated loading and unloading zones with waiting time is prohibited.

The above Section is hereby amended to read:

A. Loading and Unloading Zones

- a. Loading and Unloading Zones for Mini Bus -
 1. In front of Daytoy ti Bannawag Monument/Park going South;
 2. Service Road in front of New Public Market going North and South;
 3. In front of the Roman Catholic Church going North.
- b. Loading and Unloading Zones For Public Utility Jeepneys -
 1. In front of Delicia Building going North;
 2. Beside Peralta Building going South.
- c. Parking of vehicles other than the above-mentioned in the designated loading and unloading zones is prohibited.
