ORDINANCE NO. 10 S. 1998

REVERTING THE AMOUNT OF ONE MILLION THREE HUNDRED EIGHTY EIGHT THOUSAND SEVENTY EIGHT PESOS (P1,388,078.00) FROM THE SAVINGS UNDER PERSONAL SERVICES, MAINTENANCE AND OTHER OPERATING EXPENSES AND CAPITAL OUTLAY OF THE DIFFERENT OFFICES, 5% CALAMITY FUND AND MONEY VALUE OF LEAVE CREDITS

BE IT ENACTED by the Sangguniang Bayan of Batac, Province of Ilocos Norte, that:

Section 1. The amount of One Million Three Hundred Eighty Eight Thousand Seventy Eight Pesos (P1,388,078.00) pesos be reverted to the unappropriated surplus.

Section 2. The amount represents savings under personal services , maintenance and other operating expenses and capital outlay of the different offices , 5% Calamity Fund, and money value of leave credits which are as follows:
