ORDINANCE NO. 12 S. 1994

AN ORDINANCE AMENDING SECTION 4 OF ORDINANCE NO. 08 SERIES  
OF 1988 PROHIBITING LITTERING IN THE POBLACION AND PROVIDING  
PENALTIES THERETO

WHEREAS, the Sangguniang Bayan, as the legislative body of the Municipality, shall enact ordinances pursuant to Section 16 of the Code as provided in Rule IX of these Rules and Regulations Implementing the New Local Government Code of 1991;

WHEREAS, it is the policy of this municipality to maintain and keep in a sanitary condition the surroundings of the Municipality including the poblacion;

NOW THEREFORE:

BE IT ORDAINED by the Sangguniang Bayan of Batac, Ilocos Norte that:

Section 1. Section 4 of the Municipal Ordinance No. 8 series of 1988, which presently reads:

Any person violating this Ordinance shall suffer the following penalty:

For the first offense: A fine in the amount of TWENTY PESOS [P20.00]; For the Second Offense: A Fine in the amount of THIRTY PESOS [P30.00]; For the Third Offense: a fine in the amount of FIFTY PESOS [P50.00]; For the Fourth Offense: A fine in the amount of ONE HUNDRED PESOS [P100.00] and imprisonment of five [5] days or not less than ten [10] days; For the Fifth and succeeding offense: A fine of ONE HUNDRED PESOS [P100.00] and imprisonment for not less than Thirty [30] days;

Section 4 is hereby amended to read as follows:

Section 4: Any person violating this ordinance shall suffer the following penalties:
