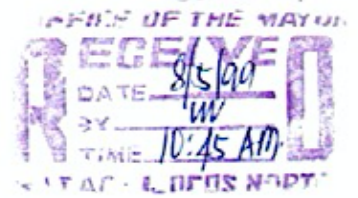

ORDINANCE NO. 12 S. 1999

AN ORDINANCE CHANGING THE RURAL HEALTH PHYSICIAN POSITION TITLE TO MUNICIPAL HEALTH OFFICER

Section 1. To date, the Municipality of Batac still officially recognize the position title of Rural Health Physician to the position of a physician in charge of the health office;

Section 2. By mandate of Section 443 of RA 7160, the above position must be entitled Municipal Health Officer;


Section 3. This Ordinance shall take effect on the day following its publication in a newspaper of general circulation in the Municipality of Batac and at the end of its posting at prominent places in the Municipality for three (3) consecutive weeks whichever occurs later.

ADOPTED THIS 2ND day of August, 1999 on joint motion of Honorables Bernardo K. Marders and Eugenia Violeta D. Nalupta.




