ORDINANCE NO. 14 S. 1999

MUNICIPAL ORDINANCE GRANTING FRANCHISE TO THE CLUSTER MARKETING WITH OFFICE ADDRESS AT SUITE 900, AYALA LIFE BUILDING, 6786 AYALA AVENUE, MAKATI CITY, A PRIVATE CORPORATION TO CONSTRUCT, INSTALL, OPERATE AND MAINTAIN A COMMUNITY ANTENNA-CABLE TELEVISION (CATV) SYSTEM WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF BATAC, ILOCOS NORTE UNDER CERTAIN TERMS AND CONDITIONS

WHEREAS, Section 447, paragraph (3), sub-paragraph (vii) of Republic Act No. 7160, otherwise known as the Local Code of 1991, provides that "Upon approval by a majority of all the members of the Sangguniang Bayan, grant a franchise to any person, partnership, corporation, or cooperative to establish, construct, operate and maintain ferries, wharves, markets or slaughterhouses, or such other similar activities within the municipality as may be allowed by applicable laws;"

WHEREAS, the CLUSTER MARKETING, with business address at Suite 900, Ayala Life Building, 6786 Ayala Avenue, Makati City, represented herein by its General Manager, Engr. Melecio, Jr., has applied for a franchise to construct, install, operate and maintain a CABLE TELEVISION (CATV) SYSTEM within the territorial jurisdiction of the Municipality of Batac, Ilocos Norte designed to (1) provide wholesome entertainment to the general public by distributing TV signals; (2) provide the general public up-to-date news both local and international; and (3) provide the public an immediate and direct source of information on various technology offered by the government and private sectors through the in-house community channel;

NOW THEREFORE

BE IT ORDAINED by the Sangguniang Bayan of Batac in session duly assembled and by authority of the same that:

SECTION 1. This franchise is hereby granted to the Cluster Marketing to construct, install, operate and maintain a Community Antenna Cable Television System within
