ORDINANCE NO. 16 S. 1999

REVERTING THE 7171-FUNDED AMOUNT OF P201,076.00 EARMARKED FOR FLUE-CURING LOAN THROUGH THE PURCHASE OF COAL BRIQUETTE UNDER APPROPRIATION ORDINANCE NO. 04 S. 1997 TO THE UNAPPROPRIATED SURPLUS

Section 1. The R.A. 7171 funded amount of P201,076.00 earmarked for the purchase of coal briquette is reverted to the Unappropriated Surplus.

Section 2. The few furnaces available constricts the fund use by more tobacco farmers who have none rendering the loan program ineffective.

Section 3. This Ordinance shall take effect upon final approval.


