**ORDINANCE NO. 6SP 2023 – 01**

**AN ORDINANCE PROHIBITING THE DISPENSING, SELLING, AND RESELLING  
OF PHARMACEUTICAL PRODUCTS IN SARI-SARI STORES AND OTHER  
SIMILAR RETAIL OUTLETS NOT LICENSED BY THE FOOD AND DRUGS  
ADMINISTRATION AND IMPOSING PENALTY THEREOF**

**WHEREAS**, the Section 15, Article II of the 1987 Constitution mandates the State to protect and promote the right to health of the people and instill health consciousness among them;

**WHEREAS**, Republic Act No. 10918, otherwise known as the "Philippine Pharmacy Act" recognizes the vital role of pharmacists in the delivery of quality health care services through the provisions of safe, effective, and quality pharmaceutical products, pharmaceutical care, drug information, patient medication, counseling, and health promotion which is indispensable component of the total health care system to ensure the physical well-being of the Filipinos;

**WHEREAS**, Section 30 of Republic Act No. 10918, prohibits the dispensing, selling, and reselling of pharmaceutical product through retail drug outlets not licensed by the Food and Drugs Administration (FDA);

**WHEREAS**, the issuance of Memorandum Circular 2022-025 instructed the Local Government Units and Local Operating Units of the Philippine National Police (PNP) to enforce the regulations set forth in Republic Act No. 10918 on the dispensing, selling, or reselling of pharmaceutical products;
