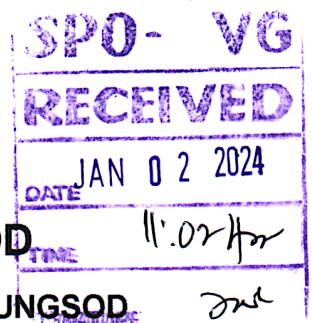

ORDINANCE NO. 6SP 2023 – 17

**AN ORDINANCE FURTHER EXPANDING THE COVERAGE OF THE BATAC
PRE-CENTENARIAN AND CENTENARIAN CITIZENS' AWARD TO INCLUDE THE
OCTAGENARIAN CITIZENS, AND TO INCREASE THE CORRESPONDING INCENTIVES
OF AWARDEES, AMENDING FOR THAT PURPOSE SECTIONS 2,5 AND 7 OF
ORDINANCE NO. 5SP 2019-10 REFERRED TO FOR BREVITY AS "THE EXPANDED
BATAC PRE-CENTENARIAN AND CENTENARIAN CITIZENS' AWARD"**

WHEREAS, on December 09, 2019, Ordinance No. 5SP 2019-10 was enacted by the Sangguniang Panlungsod of the City Of Batac which expanded the coverage of the Batac Centenarian Citizens' Award, to now include "nonagenarians" covering the age range from 90 to 95 years old, and inclusion into the category of "pre-centenarians" to those elderly in the ages of 96 and 97 years old;

WHEREAS, almost four years from the enactment of Ordinance No. 5SP 2019-10, another cluster of senior citizens to be referred to as "octagenarians" is envisioned to likewise be financially benefitted and assisted by the city government;

WHEREAS, it is within the financial capacity of the City Government of Batac to extend more benefits and compassion to this targeted segment of octagenarian senior citizens, and to increase the corresponding incentives of the awardees;

NOW, THEREFORE,

BE IT ORDAINED as it is hereby ordained, by the Sangguniang Panlungsod of the City of Batac, Ilocos Norte in session duly assembled, THAT:

SECTION 1. Section 2 of Ordinance No. 5SP 2019-10 presently reads:
