ORDINANCE NO. 6SP 2024 – 09

**AN ORDINANCE ADOPTING A UNIFIED BARANGAY CLEARANCE FORM IN THE
ISSUANCE FOR BUILDING AND BUSINESS CLEARANCE INTEGRATING IN THE
PERMITTING PROCESSES OF THE ONE STOP SHOP FOR CONSTRUCTION PERMIT
(OSCP) AND BUSINESS ONE STOP SHOP (BOSS) IN THE LGU - CITY OF BATAC,
PROVINCE OF ILOCOS NORTE**

WHEREAS, Section 4 of Article X of the 1987 Philippine Constitution provides that the President of the Philippines shall exercise general supervision over local governments. Provinces with respect to component cities and municipalities with respect to component barangays shall ensure that the acts of their component units are within the scope of their prescribed powers and functions;

WHEREAS, Section 32 of Local Government Code of 1991 (RA 7160) states that the municipality, through the city or municipal mayor concerned, shall exercise general supervision over component barangays to ensure that said barangays act within the scope of their prescribed powers and functions;

WHEREAS, under Section 11 (f) of Ease of Doing Business and Efficient Delivery of Government Service Act (RA 11032), *barangay clearances* and permits related to doing business shall be applied, issued and collected at the city/municipality in accordance with the prescribed processing time of this Act: Provided, that the share in the collections shall be remitted to the respective barangays;

WHEREAS, the Department of Interior and Local Government (DILG) through Memorandum Circular No. 2019-177 issued on October 17, 2019 provides guidelines and standard processes in compliance with the above cited provision of RA 11032;

WHEREAS, under Ordinance No. 6SP 2023-12: An Ordinance integrating the Barangay Clearance in the issuance of Business Permit and/or Building Permit, authorizing the inclusion of barangay clearance fees in the assessment of the business permit fees and/or building permit fees in the LGU - City of Batac, Ilocos Norte, and for other purposes, was approved;
