ORDINANCE NO. 6SP 2024 – 12

**AN ORDINANCE PROVIDING FINANCIAL ASSISTANCE TO INDIGENT PERSONS
WITH DISABILITY (PWD) IN THE CITY OF BATAC, ILOCOS NORTE, APPROPRIATING
FUNDS THEREFOR, PROVIDING GUIDELINES THERETO AND FOR OTHER
RELATED PURPOSES**

WHEREAS, Article II, Section 11 of the 1987 Constitution of the Republic of the Philippines declares that the State values the dignity of every human person and guarantees full respect for human rights;

WHEREAS, the protection of life, liberty and property and promotion of the general welfare are essential for the enjoyment by all the people of the blessings of the democracy as stated in Article II, Section 4 of the Constitution;

WHEREAS, the Department of Social Welfare and Development abbreviated as "DSWD" as the leader in social protection is mandated to contribute to better and improved quality life for the citizenry where priority attention shall be given to the poor, vulnerable and marginalized sectors of the society. Hence, it implements social welfare, social protection and anti-poverty programs, projects, activities and services;

WHEREAS, the Persons with Disabilities (PWDs) which include those who have long-term physical, mental, intellectual or sensory impairments are experiencing with various barriers as to their mobility that may hinder their full and effective participation in the society on an equal basis with others;

WHEREAS, despite of their disabilities and incapacities, they are important in nation-building and they shall enjoy their rights and privileges as stipulated in RA 7277, otherwise known as the "Magna Carta for Disabled Persons", as amended in 2007 by RA No. 9442, as well as RA 10754 entitled, "An Act Expanding the Benefits and Privileges of Persons with Disability (PWD)";
