ORDINANCE NO. 6SP 2024 - 13

AN ORDINANCE CREATING THE CITY KONSULTA TRUST FUND OF THE CITY OF BATAC AND AUTHORIZING THE CITY MAYOR ALBERT D. CHUA TO EXECUTE AND SIGN, FOR AND ON BEHALF OF THE LGU - CITY OF BATAC, A MEMORANDUM OF AGREEMENT WITH MARIANO MARCOS MEMORIAL HOSPITAL AND MEDICAL CENTER REPRESENTED BY REGIONAL DIRECTOR IV/OVERSEER DR. PAULA PAZ M. SYDIONGCO, MD, MBA CESO IV AS THE REFERRAL FACILITY ON THE OUTSOURCED LABORATORY AND DIAGNOSTIC SERVICES AND DRUGS/ MEDICINES/ SUPPLIES FOR THE IMPLEMENTATION OF KONSULTA PACKAGE OF REPUBLIC ACT NO. 11223 IN THE CITY OF BATAC, ILOCOS NORTE

WHEREAS, R.A. 11223 otherwise known as the National Health Insurance Act of 2019 provides the creation of the new KONSULTA (Konsultasyong Sulit at Tama) PACKAGE which shall provide primary healthcare benefits coverage and ensure affordable, acceptable, available, and accessible healthcare services for all citizens of the Philippines;

WHEREAS, the creation of the City KONSULTA Trust fund for the City Government of Batac is necessary for easy monitoring of PhilHealth for the services provided by the facility to its members that will facilitate faster reimbursement transactions;

WHEREAS, the KONSULTA Trust fund will cover all the Laboratory and Diagnostic Services and medicines listed in the PhilHealth KONSULTA Package. This will also serve as the basis of PhilHealth in the reimbursements of the expenses incurred by the patients;

WHEREAS, to address the temporary deficiencies of the City Health Office of the City of Batac that will eventually be qualified as an accredited KONSULTA provider of the National Health Insurance Program (NHIP). MMMH&MC shall be the referral facility to be contracted through a Memorandum of Agreement and will provide the laboratory and diagnostic tests and medicines needed by the patients opted to be served by the City Health Office;
