## **ORDINANCE NO. 6SP 2024 - 15**

## AN ORDINANCE REQUIRING THE BASIC IMMUNIZATION OF DAY-CARE CHILDREN AS A PRE-REQUISITE FOR THE ENROLLMENT IN ALL PUBLIC AND PRIVATE CHILD DEVELOPMENT CENTERS IN THE CITY OF BATAC

WHEREAS, Section 15, Article II of the 1987 Constitution declares the policy of the State to take a proactive role in the preventive healthcare of infants. The state shall adopt a comprehensive, mandatory and sustainable immunization, program for vaccine-preventable diseases for all infants;

WHEREAS, Republic Act No. 10152 otherwise known as, "Mandatory Infants and Children Health Immunization Act of 2011" was enacted to mandate the State to adopt a comprehensive mandatory and sustainable immunization program for vaccine-preventable diseases for all infants and children;

WHEREAS, the City Government of Batac commits to scaling up immunization intervention programs and allocating resources in a sustainable manner to improve the immunization status, address vaccine-preventable diseases of infants to ensure the growth and development of young children;

## NOW, THEREFORE,

**BE IT ORDAINED,** by the Sangguniang Panlungsod of the City of Batac, Ilocos Norte in session duly assembled, that:

Section 1. Title. This Ordinance shall be known as "Mandatory Immunization of Pre-School Children."

**Section 2. Declaration of Policy**. The City Government of Batac, upholding the fundamental principle of the right to health guaranteed by Section 15, Article II of the 1987 Constitution, commits to protect and promote the right to health of the people, especially children, and instill health consciousness among them.
