ORDINANCE NO. 6SP 2025 - 05

AN ORDINANCE GRANTING TAX AMNESTY ON PENALTIES, SURCHARGES AND INTERESTS INCURRED FROM DELINQUENT REAL PROPERTY TAXES IN THE CITY OF BATAC PURSUANT TO REPUBLIC ACT NO. 12001, OTHERWISE KNOWN AS THE REAL PROPERTY VALUATION AND ASSESSMENT REFORM ACT (RPVARA)

WHEREAS, Republic Act No. 1200, also called Real Property Valuation and Assessment Reform Act, mandates the reform of real property valuation and assessment practices across the country;

WHEREAS, Section 14 of Republic Act No. 12001 authorizes Local Government Units to grant tax amnesty on penalties, surcharges and interests incurred from delinquent real property taxes, including Special Education Fund (SEF), Idle Land Tax, and other Special Levy Taxes;

WHEREAS, the City Government of Batac recognizes the importance of providing relief to taxpayers who have incurred penalties, surcharges and interests on delinquent real property taxes due to various circumstances, including economic challenges;

WHEREAS, granting a tax amnesty will encourage compliance among taxpayers, facilitate the collection of overdue taxes, and ultimately contribute to the financial well-being of the City;

NOW, THEREFORE,

BE IT ORDAINED, by the Sangguniang Panlungsod of the City of Batac, Ilocos Norte, in session duly assembled, that:

SECTION 1. **SHORT TITLE.** This Ordinance shall be known as the "City of Batac Tax Amnesty Ordinance of 2025."
