# **ORDINANCE NO. 6SP 2025 - 06**

### AN ORDINANCE GRANTING AN INCENTIVE FUND TO BARANGAYS IN THE CITY OF BATAC ACHIEVING THE SEAL OF GOOD LOCAL GOVERNANCE (SGLG) NATIONAL PASSERS

**WHEREAS**, the Seal of Good Local Governance (SGLG) is program that recognizes and incentivizes outstanding performance of local government units (LGUs) across various governance areas;

**WHEREAS**, the City of Batac is committed to promoting good governance at the barangay level by encouraging and rewarding exceptional performance through the SGLG;

**WHEREAS**, it is necessary to establish a system to provide financial incentives to barangays that attain the SGLG National Passer status;

#### NOW, THEREFORE,

**BE IT ORDAINED,** by the Sangguniang Panlungsod of the City of Batac, Ilocos Norte, in session duly assembled, that:

#### **SECTION 1. Definition of Terms**

#### "SGLG National Passer"

A barangay that has successfully passed all the assessment criteria set by the Department of Interior and Local Government (DILG) to be awarded the Seal of Good Local Governance at the national level.

#### "Incentive Fund"

A designated fund allocated by the City Government to be distributed to SGLG National Passer barangays as counterpart fund to support the PCF/SGLGIF which is an incentive given in the form of a financial grant to eligible LGUs under the Local Governance Performance Management Program (LGPMP) of the DILG.
