ORDINANCE NO. 6SP 2025 - 07

AN ORDINANCE ESTABLISHING THE GUIDELINES IN THE IMPLEMENTATION OF CRISIS ASSISTANCE TO RESPOND EMERGENCY SITUATION (CARES) IN THE CITY OF BATAC, ILOCOS NORTE

WHEREAS, the City of Batac, Ilocos Norte recognizes the importance of providing support and assistance to its constituents who are in crisis situations;

WHEREAS, there is a need to establish guidelines for the implementation of a program to be availed of in time of exigencies known as Crisis Assistance to Respond Emergency Situation (CARES) in the City of Batac, to ensure that the program is implemented effectively and efficiency;

NOW, THEREFORE,

BE IT ORDAINED, by the Sangguniang Panlungsod of the City of Batac, Ilocos Norte, in session duly assembled, that:

SECTION 1. PURPOSE. The ordinance aims to establish the guidelines for the implementation of the Crisis Assistance to Respond Emergency Situation (CARES) in the City of Batac.

SECTION 2. DEFINITION OF TERMS. For the purpose of this ordinance, the following terms are defined:

A. Client - Refers to an individual or group of individuals who seeks assistance for himself/herself or on behalf of the beneficiary, due to their inability to be physically present.
