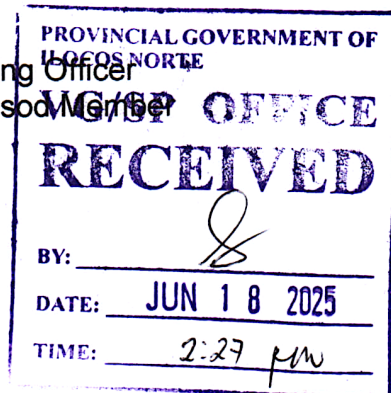

**ORDINANCE NO. 6SP 2025 – 10**

**AN ORDINANCE INSTITUTIONALIZING THE PROGRAMS, SERVICES, PRIVILEGES  
AND BENEFITS FOR SOLO PARENTS AND THEIR CHILDREN IN THE CITY OF BATAC,  
ILOCOS NORTE, AND APPROPRIATING FUNDS THEREOF AND FOR OTHER  
PURPOSES PURSUANT TO REPUBLIC ACT 8972, ALSO KNOWN AS THE  
“SOLO PARENT ACT OF 2000”**

**WHEREAS**, under R.A. No. 8972 otherwise known as the Solo Parent Act, it is a declared policy of the State to promote the family as the foundation of the nation, strengthen its solidarity and ensure its total development. Towards this end, it shall develop a comprehensive program of services for solo parents and their children;

**WHEREAS**, solo parents bear the heavy burden raising the family and providing their children a better future; single-handedly do parental duties in the face of privation and poverty;

**WHEREAS**, the Local Government Unit of the City of Batac (LGU-City of Batac), acknowledges the plight of the solo parents in providing decent living conditions for their children;

**WHEREAS**, LGU-City of Batac, shall undertake measures to ensure the needs of the solo parents and their children are within reach pursuant to R.A. No. 8972 known as the Solo Parents Welfare Act of 2000;

**WHEREAS**, R.A. No. 7160 otherwise known as the Local Government Code of 1991, provides that “The Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the city and its inhabitants”;
